






Fig. 8.7 C - V_{CE}




Fig. 8.9 Switching Time - I_C




Fig. 8.11 Reverse Bias SOA (Guaranteed Maximum)




Fig. 8.8 Switching Time - RG




Fig. 8.10 Safe Operating Area (Guaranteed Maximum)




Fig. 8.12 $r_{th(j-c)}$ - t_w (Guaranteed Maximum)


